We are committed to **making the world a better place** through solar energy, biomass heating, an extensive recycling program and environmental innovations that make us business leaders in the field. An array of 418 rooftop solar panels helps to power our Montpelier headquarters while 20 solar thermal panels provide hot water and a \$2 million biomass boiler heating system provides more than 90 percent of the heat. National Life's shredded paper is used as bedding for 700 milking cows at a local dairy farm. In 2009 the U.S. Green Building Council awarded National Life's headquarters a coveted silver certification under the Council's Leadership in Energy and Environmental Design (LEED) rating system.
